As part of the 2021 Community Development Block Grant (CDBG) Method of Distribution (MoD) funding cycle, the Wyoming Community Development Authority (WCDA) Neighborhood Development Division is announcing the availability of funding under three sources:

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) - 2020 PROGRAM YEAR (PY)

ALL FUNDING IS SUBJECT TO FINAL ALLOCATION TO OUR STATE FROM HUD.

There will be \$3,216,677 available in PY2020 CDBG funds for eligible activities identified in the 2021 CDBG MoD. Funding may be limited within specific set-aside categories.

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) - 2021 PROGRAM YEAR (PY)

ALL FUNDING IS SUBJECT TO FINAL ALLOCATION TO OUR STATE FROM HUD.

There will be \$3,657,587 available in PY2021 CDBG funds for eligible activities identified in the 2021 CDBG MoD. Funding may be limited within specific set-aside categories.

**COMMUNITY DEVELOPMENT BLOCK GRANT CARES ACT (CDBG-CV) -
2020 PROGRAM YEAR**

ALL FUNDING IS SUBJECT TO FINAL ALLOCATION TO OUR STATE FROM HUD.

There will be \$5,596,234 available in PY2020 CDBG-CV funds for eligible activities identified in the 2021 CDBG MoD. Funding may be limited within specific set-aside categories.

Note that a recipient may not commit HUD assistance funds until an Environmental Review has been conducted and HUD has approved the recipient's Request for Release of Funds (RROF). Until the RROF and related certification has been approved, the recipient may not commit non-HUD funds on an activity if the activity or project would have an adverse environmental impact or limit the choice of reasonable alternatives.

LETTERS OF INTENT AND APPLICATIONS

Letters of Intent must be received by 5:00 p.m. MDT on Tuesday, August 31, 2021. Applications for the CDBG and CDBG-CV programs must be received by WCDA via the ProCorem WorkCemter on or before 5:00 p.m. MDT on Thursday, September 30, 2021. Late applications will not be ranked. It is anticipated that 2021 MoD cycle funding will be awarded in January 2022.
