

Racial Characteristics:

Of the people living in this area in 2020, **88.92%** are White, **0.61%** are African American, **9.7%** are Hispanic, **0.39%** are Asian, **0.01%** are either Native Hawaiian or Pacific Islander, **0.89%** are American Indian or Alaskan Native, **3.62%** are of "some other race" and **5.56%** are of two or more races. In the table below, the percentage of the population that each segment represents in the report area is compared to the percent it represents in the state.

Between 2010 and 2020, the White population changed by **-11.28%**, the African American population by **-3.8%**, and Asian population by **19.51%**. The number of Hispanics changed by **-5.9%**.

In the report area in 2017-2021, 21.86% of the population is over the age of 65. 58.11% are of working age (18-64). 20.04% are under 18, and 5.86% are under 5 years old.

Incomes:

The median household income for the study area was **\$58,318**, compared to the state of Wyoming with a median of **\$68,002**, as estimated for 2017-2021 by the Census' American Community Survey.

The number of households divided by income categories is shown in the Annual Income Category table. In the period of 2017-2021, **43.37%** of households in the study area had an annual income of less than \$50,000, compared to **36.2%** of people in the state of Wyoming.

Immigration:

Data from the U.S. Census Bureau for 2017-2021 indicate that **248** people or **1.96%** of the population living in this area were "foreign born". Census defines foreign born as anyone who is not a U.S. citizen at birth. This area is located in Wyoming, which, according to the Department of Homeland Security, was home to **444** people who were granted Legal Permanent Residence status in 2017. Those LPRs, or "green cards", represent **0.04%** of green cards issued in the nation that year.

Families and Households:

The composition of the **3,305** families who reside in the study area is shown in the table below. Families are groups of related people who live together, whereas households refer to the person or group of people living in any one housing unit. Generally, households that do not contain a family are made up of unrelated people living together (eg, roommates) or people living alone. While it is possible for two families to share a household, the difference between the number of households and the number of families in an area shows, approximately, the number of non-family households in a place.

Housing Type:

The type of housing available in this area is described in the table below. Single family homes include all one-unit structures, both attached and detached. Townhouses or duplexes include one-unit attached homes, as well as housing units with two units. Units in small apartment building are buildings with 3 to 49 units; large apartment buildings include buildings with 50 units or more. Other types of housing include vans, boats, recreational vehicles, or other units.

Tenure:

Across the area, an estimated **74%** or **3,672** households owned their home between 2017-2021. The average size of a household in this area was **2.37** between 2017-2021, as compared to the average household size for the county and the state, **2.37 (Goshen)** and **2.44 (Wyoming)** respectively.

Postal vacancy shows short-term vacancy trends based on addresses where mail has not been collected for over 90 days. Data from Valassis Lists tracks vacancy on a quarterly basis. In the 1st quarter of 2023, the overall vacancy rate in this area was **4.72%**.

Endnotes:

Calculations presented here were performed by staff at PolicyMap and are based on public and proprietary data sources.
