#### Incomes:

The median household income for the study area was \$74,835, compared to the state of Wyoming with a median of \$68,002, as estimated for 2017-2021 by the Census' American Community Survey.

The number of households divided by income categories is shown in the Annual Income Category table. In the period of 2017-2021, **28.47**% of households in the study area had an annual income of less than \$50,000, compared to **36.2**% of people in the state of Wyoming.

#### Immigration:

Data from the U.S. Census Bureau for 2017-2021 indicate that **533** people or **2.74%** of the population living in this area were "foreign born". Census defines foreign born as anyone who is not a U.S. citizen at birth. This area is located in Wyoming, which, according to the Department of Homeland Security, was home to **444** people who were granted Legal Permanent Residence status in 2017. Those LPRs, or "green cards", represent **0.04%** of green cards issued in the nation that year.

#### Families and Households:
